Technical – Practical Arrangement - Shooting Competition

Competition Officials: Range conducting officer, Chris Stafrace

The decision of the organising committee shall be final.

Weapons: Every participant is to bring along with him his own pistol which has to be duly licensed in his name according to law in his respective country. A true certified copy of the original license is one of the documents required by the organisers when participants submit their registration forms.

Pistols required:

Can be - Single action, double action, double action only or safe action (when trigger is pulled the hammer /striker is cocked and then released).

Shotgun: A shotgun plus 12 gauge rounds will be provided free for use by the organizers.

Ammunition: 100 rounds of ammunition will be required for the whole event.

Calibre: 9mm or larger

Safety: For safety and precautionary measures and to obtain the same chronograph level, thus giving all competitors every chance to achieve maximum velocity whilst shooting with their respective firearm and to avoid improperly reloaded ammunition, **one hundred factory loaded ammunition will be provided for practice and the competition by the organizers at the range.**

Disciplines: Individual Pistol Shooting
Team tactical Pistol and Shotgun.

Awards:

- 1st, 2nd and 3rd Individual. (Pistol)
- 1st, 2nd and 3rd Team (Pistol and Shotgun)
- All competitors will be given a memento for their participation.

The overall best shooter of the individual competition will be presented with a **12.gauge pump action shotgun and a trophy.**

Range clothing and equipment

- 1 x Duty type holster.
- 1 x Pistol belt
- 1 x Ear Protection.
- 1 x Pair of knee pads.
- 1 x Double magazine pouch
- 2 x Spare magazines
- 1 x Eye Protection.
- Range clothing & Wet weather clothing

Language: English will be the competition language and a fairly good command of the English language is essential to understand the rules and safety instructions.

Shooting Insurance Policy: It is imperative that every competitor **MUST** produce from his own country, **an authentic document** showing **an extension of his Personal Accident and Personal Liability insurance**, specifically indicating and covering the competition days 26th and 27th April 2012, being held in Malta.

If such insurance is not provided by participants, arrangement have been made with Elmo Insurance (Malta) who can provide a Personal Accident & Personal Liability Insurance (accidental bodily injury to persons and/or accidental damage to property) at a cost of **€30** as per terms below:

- a) Death: € 23,300 per person
 - b) Permanent Disability: € 23,300 per person
 - i) Loss of two or more limbs or both eyes €23,300
 - ii) Loss of one limb or eye € 11,650
 - iii) Permanent Total Disablement other than by loss of limb or eye from gainful employment of any and every kind: € 23,300
 - c) Personal Liability: € 116,500 per person
- Premium: €25.00 plus € 5 stamp duty & fee – **Total €30.00 per person**
Excess: € 115

Please note that no one will be **permitted to enter** the shooting range if not in possession of a **valid insurance policy**. We are being very strict about this because unless all the relative requested documents are in order and in hand with the organisers before the competition starts, **participation will be strictly denied**.

Health Insurance: Participants coming from an EU country are advised to bring along with them the EU Health Card. However private travelling insurance is always recommended.

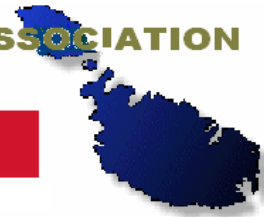

Travel & Accommodation

Travel Arrangements

We are pleased to inform you that AirMalta is the Official Carrier for this meeting and passengers will be offered a 10% discount on published pricing for travel on national carrier scheduled services when booking online through AirMalta B2B booking engine, using a pre defined user name and password, which offer will be applicable as from June 2011.

In June the booking engine will be activated and an updated Travel Page will be sent to you, which will then include the user name and password to be used by participants, spouses, and accompanying friends, to book their flights.

Accommodation

We are pleased to accommodate participants at the Phoenicia Hotel, Floriana on a double room basis. Supplement for single room will be charged separately from the package as being indicated here under.

Two contestants from each European Section will be accommodated on a double room basis, on the 25th, 26th, and 27th at a package cost of **€385**.

Extra night: For those wishing to extend their stay in Malta including visitors, before or after the event, hotel rates are as follows:

1. Single room B&B: Euro 95 / per night per person.
2. Double room B&B: Euro 60 / per night per person
3. *Single room supplement for participants and guests on the 25th 26th and 27th only, is €60 per night per person, in addition to the package.*

Booking deposit: Upon submitting your registration form **Annex 4** for the competition a payment deposit of €100 is to be forwarded to the National Treasurer Joe Mamo. Failing to effect the deposit payment by the **15th January 2012**, this will terminate the reservation booking with the hotel. Deposit sum is not refundable.

Package full payment balance is to be effected by the **15th February 2012**.

Reservation cancellation policy: Cancellation of the booking between the **16th February and 15th April 2012** is charged with a cancellation fee of 50 euro.

Cancellation of the booking between the **16th April and the 25th April 2012** is charged with a cancellation fee of 100 euro.

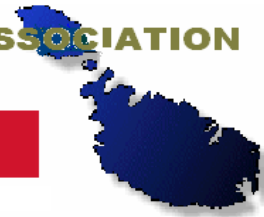

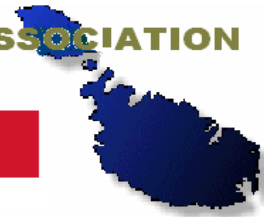

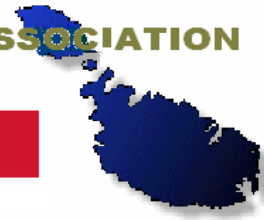
